STEP 1

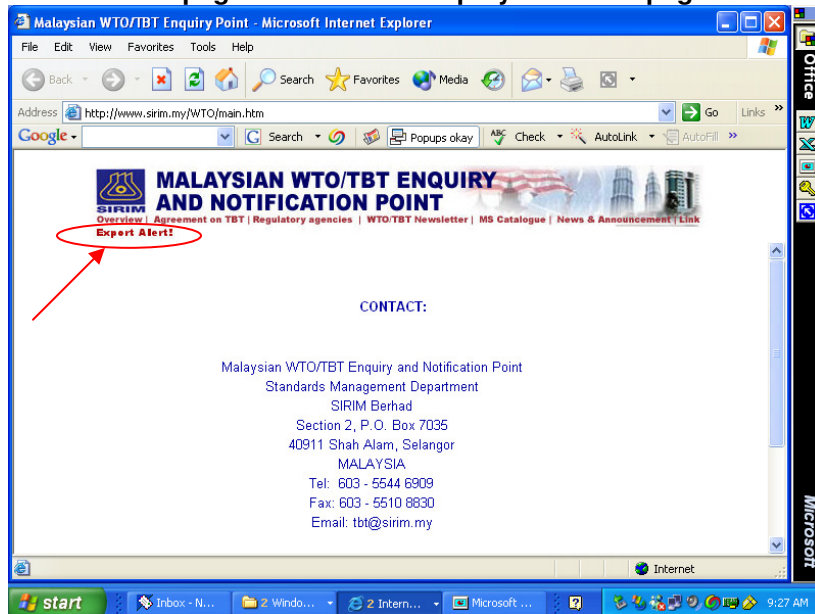

Click at "Export Alert!" (as shown below)

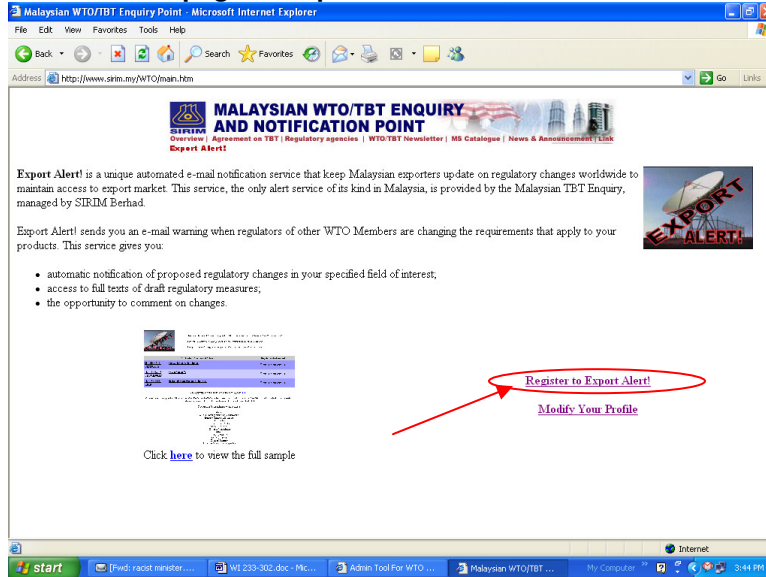
Screen: Main page of WTO/TBT Enquiry Point webpage



STEP 3

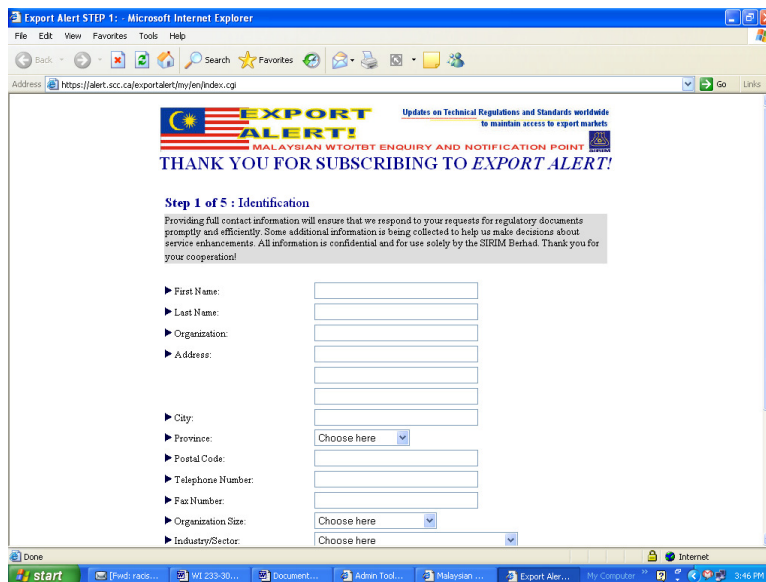
Click at "Register to Export Alert!" (as shown below)

Key in you details (Step 2 of 5: Country of Interest) (as shown below)

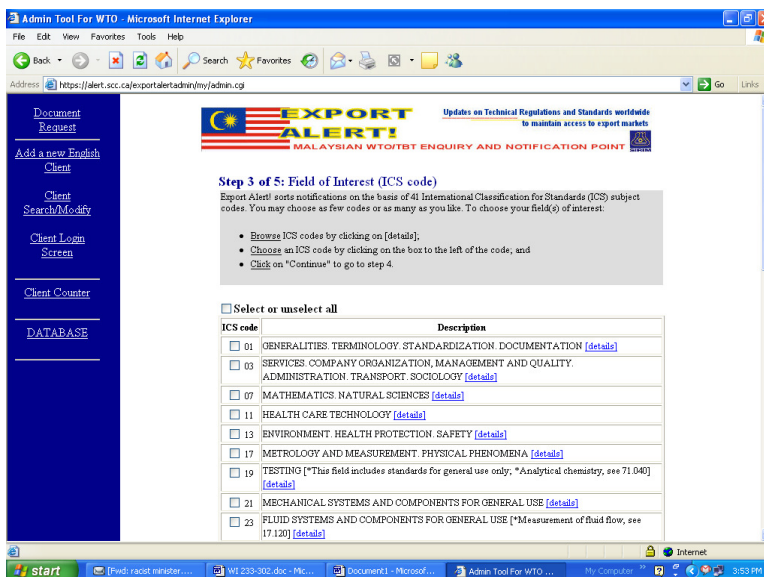
Choose the country(ies) you would like to receive notification from OR you can click the “select all” tab.



STEP 6

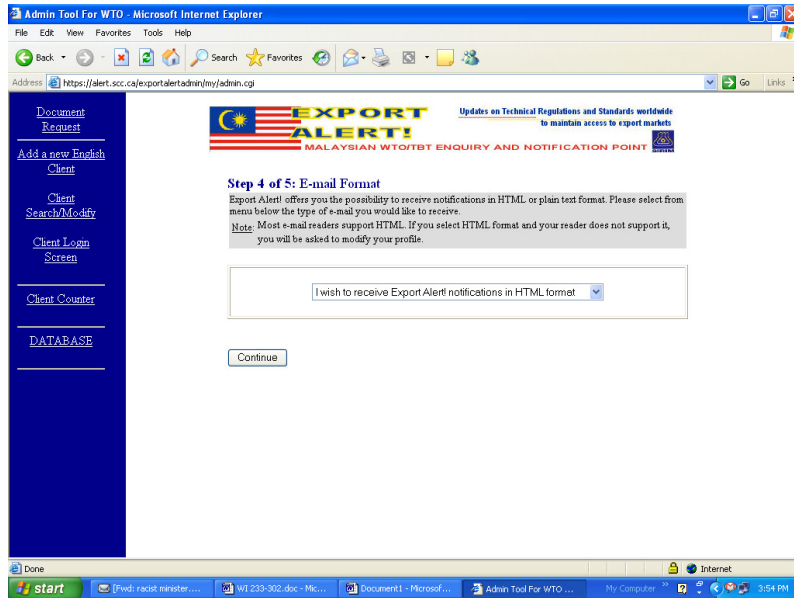
Key in you details (Step 3 of 5: Field of Interest) (as shown below)

Choose the specific sector(s) of interest to you OR you can click the “select all” tab.



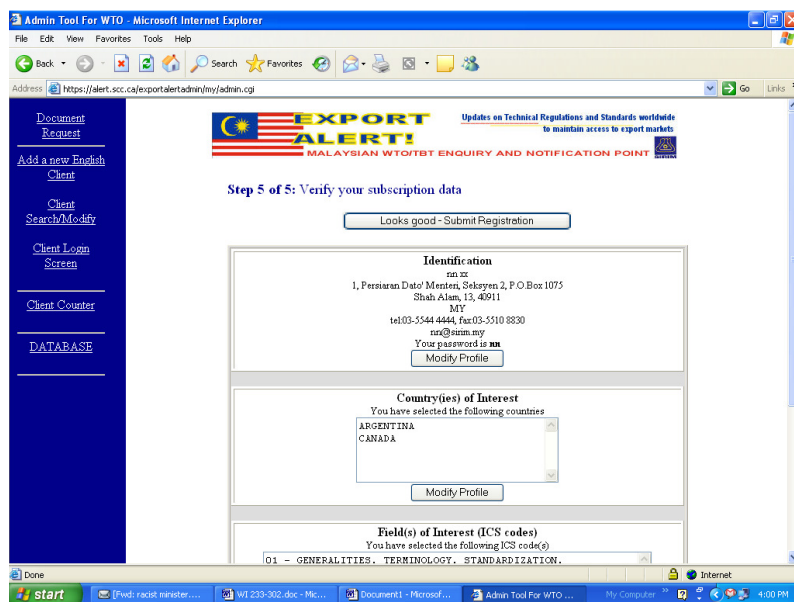
STEP 7
